#### **Announcement**

Pursuant to Article 4 of Law no. 4/93 (The Environmental Protection and Preservation Act), by the power vested in this ministry, the following areas have been proclaimed as protected as of 23<sup>rd</sup> December 2021. These places will be maintained according to the guideline pertaining to the protection and preservation of the nature of such places (guideline no: 2018/R-78).

## 1. L. Gan Boda Fengan'du Area

- a. Name of area to be protected: L. Gan Boda Fengan'du Area
- b. Parameters of the region to be protected and details of zonation:

c. Reasons why this site was determined as an area that needs to be protected and sustained in its natural state and its unique features:

L. Gam Boda Fengan'du is a 'golden' body of water on the east side of Kuda Hinna. It is also known as 'Paree Fengan'du' (Fairy Pond) or 'Naraka Fengan'du' (Hell Pond). This body of water is closely linked to the history of this island, and has many folk tales related to it. It is notable that out of species of trees that grow in lakes, mangroves and wetlands, red mangroves grow here. Moreover, fish poison trees also grow in the areas surrounding it. This environment is crucial to the safety of protected and seasonal birds that visit the Maldives. It has also been recorded that white-tailed tropic birds lay eggs and breed in this environment. Additionally, the lake, mangrove, and wetland area help keep the water layer of the island fresh and plays an important reducing the chances of flooding in the island. It is also a 'carbon sink' that traps carbon dioxide there, and contributes to lowering global warming

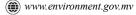

c. Reasons why this site was determined as an area that needs to be protected and sustained in its natural state and its unique features:

Zone 1 – Maabaidhoo Koaru Area:

The Maabaidhoo Koaru Area is a saltwater lake connected to the ocean on the north side of L. Maabaidhoo. Because this lake is connected to the ocean, it plays the role of a nursery for reef life to populate. Out of trees that grow in lake, mangrove, and wetlands, red mangroves (Rhizophora mucronata) and yellow mangroves (Ceriops tagal) have been recorded to grow here. The seagrass in this zone provides food for the turtles and tortoise species here and is a vital area for their survival. It has been recorded that the reef and seagrass area of this island contains 6 types of seagrass, and 86 species of reef fish have been observed. Besides this, the lake, mangrove, and wetland area help keep the water layer fresh, prevent the island from eroding, and plays an important role in reducing the chances of flooding in the island. Additionally, it is also a 'carbon sink' that traps carbon dioxide there, and contributes to lowering global warming.

#### Zone 2 - Fushi Kandu Area:

I. Fushi Kandu is an atoll entrance in the northeast of Haddhunmathi. This atoll entrance is home to a diverse variety of marine life, that use its reef to reproduce, and is famous among divers. Green turtles (Chelonia mydas), Hawksbill turtles (Eretmochelys imbricate), Reef Manta Rays (Mobula Alfredi), other types of rays, and species of sharks that are in danger of going globally extinct, and are protected in the Maldives have been recorded to be seen here.

c. Reasons why this site was determined as an area that needs to be protected and sustained in its natural state and its unique features:

The L. Vadinolhu atoll entrance is an atoll entrance in the northwest of Haddhunmathi. This atoll entrance hosts a variety of marine life and is popular among divers. This area is also frequented by groupers and Napoleon wrasses to breed. Moreover, Reef Manta Rays (Mobula Alfredi), Hawksbill turtles (Eretmochelys imbricate), and Green turtles (Chelonia mydas), and different species of sharks that are in danger of going globally extinct, and are protected in the Maldives have been recorded to be seen here. Ainmathee birds come to the island to the big sandbank in this area to sleep and lay eggs.

Name of area to be protected: L. Gaadhoo Turtle Nesting Area, Mangrove, and Seagrass Area



b. Parameters of the region to be protected and details of zonation:

#### L. Gaadhoo Turtle Nesting Area, Mangrove, and Seagrass Area Figure 5

- c. Reasons why this site was determined as an area that needs to be protected and sustained in its natural state and its unique features:
  - L. Gaadhoo is an island that was declared uninhabited in 2016, which was previously populated.
  - 1. South and west beach: This is an area that has been visited by turtles to lay eggs and reproduce for many years in the Maldives. Hawksbill turtles (Eretmochelys imbricate) and Green turtles (Chelonia mydas) are the species of turtles that have been recorded to lay the greatest number of eggs here. They are both species that are protected in the Maldives and endangered globally.
  - 2. The reef and seagrass area surrounding the island: This is an important area that supplies food to species of turtles and aids their survival. Moreover, the seagrass area is used by reef fish as an environment for reproduction. It is also a 'carbon sink' that traps carbon dioxide to lower global warming. The seagrass area surrounding this island has been recorded to be home to 6 types of seagrasses and 91 species of reef fish.
  - 3. Lake, mangrove, and wetland area: This lake is a freshwater lake located in the wetland in the east side of the island. Places such as this help keep the water layer of the island fresh and reduce the chances of flooding in the island. Black mangrove, which is commonly found in lake and mangrove areas like this, also grow here in large numbers. Moreover, this area is crucial for the preservation of environments of seasonal and protected birds that visit this area.

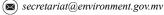

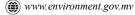

c. Reasons why this site was determined as an area that needs to be protected and sustained in its natural state and its unique features:

Gaadhoo – Hithadhoo Sea in the south corner of Haddhunmathi, and between Gaadhoo and Hithadhoo, is home to an array of living things. This area has been recorded to be visited frequently by reef fish to release their eggs and reproduce. Out of the important species that can be seen here, those that are protected in the Maldives include Green turtles (Chelonia mydas), Hawksbill turtles (Eretmochelys imbricate), Reef Manta Rays (Mobula Alfredi), and Napoleon Wrasses (Cheilinus undulates). Besides this, various types of sharks, Whale sharks, and rays have also been recorded to be seen here. These species are in danger of going extinct internationally, and so it is crucial that this area be protected to maintain their population.

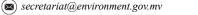

Out of trees that grow in lake, mangrove, and wetlands, red mangroves (Rhizophora mucronata), yellow mangroves (Ceriops tagal), and Black mangroves (Lumnitzera racemose) have been recorded to grow here. Additionally, the lake, mangrove, and wetland area help keep the water layer fresh, prevent the island from eroding, and plays an important role in reducing the chances of flooding in the island. It is also a 'carbon sink' that traps carbon dioxide and therefore contributes to reducing the effects of global warming.
